In this advanced class, I used a variety of primary and secondary sources handling themes about aesthetic representations of violence in American culture in order to introduce students to critical analysis in a college setting. We then carried this emphasis on analysis into their written assignments in which they had to form and support an interesting and implicit thesis about our primary materials, culminating in a longer paper which required them to perform original research on the topic of serial killing and popular culture. In this course, students spend much more time examining and analyzing literature and scholarly materials than in a typical freshman composition course, encouraging them to participate in scholarly discourse on the subject matter.

Associate Instructor-C103 Zombies and the Cultures of Fear

Taught two sections of a course for the College of Arts and Sciences which introduces freshman students to the methodologies and ends of humanities study.
